## REPORTS AND COMMITTEE REPORTS

#### PRESIDENT'S REPORT-

This year went fairly well, there wasn't much change from last year. Our finances are healthy. The league still requires additional volunteers for the board. Fred Spiring will not be on the board for 2018. The MSSTL website has been operational for over a year and many positive comments were received from a number of teams.

#### SOFTBALL MANITOBA REPORT

Don Klym was unable to attend but submitted a report that was read by Les Newman. Don thanked the membership and congratulated all the teams that participated in the Provincials. He asked for comments regarding the past year or providing suggestions for improvements.

There were several comments from the floor stating that expanding the provincial tournament to three days was a positive change.

#### WINNIPEG LEAGUE TOURNAMENT

Ross MacIver reported that the tournament at Blumberg was a success. Eighteen teams participated in four divisions.

#### **RULES COMMITTEE and UMPIRES**

- Cancellation Policy Several proposed changed were discussed. These changes were available for review on line prior to the AGM.

- 3.) Polar Bear Fund Disbursement Policy This formal policy was presented by Ross MacIver and was available on line prior to the AGM. Under the current policy only two teams had requested funds from it. Ross suggested alternative use for the funds and suggested that everyone bring suggestions to the April 2018 AGM for consideration. No vote was taken.
- 4.) Umpires Report Henry Rosentreter was unable to attend and will present a report at the Spring AGM. The general discussion from the floor included suggestions that "more umpires get out from behind the plate."
  - It was requested that Henry review the MSSTL rules with the umpires so that they understand and are able to apply our league rules as expected, including those that are unique to MSSTL. Another request concerned the application of the pitch arc rule and that it be applied consistently by all umpires.

It was suggested that all teams ensure that new players are advised of the league rules to ensure their understanding and compliance of all MSSTL playing rules.

## 2018 TOURNAMENT SCHEDULE

Les Newman mentioned that there were some contact changes and to let him know of any tournament changes to the tentative tournament schedule for 2018.

The league tournament organizing group will be determined at the April 2018 AGM.

The 2018 Canada 55+ Games will be held in Saint John New Brunswick from August 21 -24.

#### 2018 SOFTBALL MANITOBA PROVINCIAL TOURNAMENT

At this time it was agreed that MSSTL recommend the tournament dates as Aug. 28-30 to Softball Manitoba. (Note tournament motion at end of minutes.)

#### 2018 SOFTBALL MANITOBA REGISTRATION FORM

A request had been made by the league to modify the Team Registration Form (TRF) so that player/coach address information would not be required. Softball Manitoba responded that they/we would be unable to obtain any insurance coverage if this change were to occur.

There was a brief discussion about Softball Manitoba implementing a Registration card or wrist band process for players to have with them. This may come in 2018. More information will be available at the April 2018 AGM.

## SOFTBALL MANITOBA REQUIEMENT FOR PLAYERS HELMETS

The league received a memo from Softball Manitoba regarding the proposed requirement that slo pitch players wear helmets for safety measure. After reviewing and discussing the memo the league consensus was that use of helmets not be a mandatory practice and that it be up to the individual player to decide whether to use a helmet at any time.
